Ar ei ffurf bresennol nid oes digon o weledded wrth fynd i'r A40 o Heol Rhos, foddy bynnag nid oes unrhyw rwystrau i oresgyn hyn. Byddai cynllun a gynlluniwyd yn ofalus yn caniatáu cynnydd yn y lleiniau gwelededd er mwyn diogelu datblygiad priodol.
In its current form there is insufficient visibility onto the A40 from Heol Rhos, however there are no impeding obstacles to overcome this. A carefully designed scheme would allow an increase to the visibility splays to safeguard an appropriate development.

Fydd rhaid i unrhyw gais cynllunio ar y safle nodi a oes digon o ddarpariaeth man agored yn yr ardal a sicrhau ei bod yn unol â'r polisi Mannau Agored.

This site is not within a reasonable walking distance to an open space provision and does not utilise previously developed land. It otherwise performs positively against the SA Framework. Any proposed application on the site would need to identify if there is sufficient open space provision in the area and ensure accordance with the Open Space policy.
