

PUBLIC NOTICE
THE COUNTY OF CARMARTHENSHIRE
(LEVEL CROSSING, CHURCH ROAD, BURRY PORT)
(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2025

WHEREAS the Carmarthenshire County Council (hereinafter referred to as "the Council") being the Highway Authority for that length of Church Road, Burry Port from its junction with Heol Y Bardd for a distance of 40 metres in a northerly direction across the level crossing, are satisfied that traffic in the said length of road should be restricted by reason of the works proposed to be executed thereon.

NOW therefore the Council in exercise of their powers under Section 14(1) of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers hereby make the following Order:-

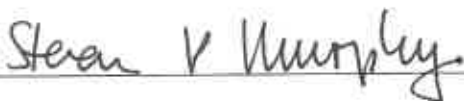
1. No person shall cause any vehicle to proceed along that length of the Road known as Church Road, Burry Port from its junction with Heol Y Bardd for a distance of 40 metres in a northerly direction across the level crossing.
2. This Order shall come into operation on the Thirtieth of October Two Thousand and Twenty-Five and may be cited as The County of Carmarthenshire (Level Crossing, Church Road, Burry Port)) (Temporary Prohibition of Through Traffic) Order 2025.

2. Bydd y Gorchymyn hwn yn dod i rym ar y degfed ar hugain o Hydref Dwy Fil a Dau Ddeg Pump a gellir cyfeirio ato fel Gorchymyn Sir Gaerfyrddin (Croesfan Reilffordd, Heol yr Eglwys, Porth Tywyn) (Gwaharddiad Dros Dro Ar Draffig Trwodd) 2025.
