

THE COUNTY OF CARMARTHENSHIRE
(THE C1301 LLANPUMSAINT TO BANCYFFORDD, CARMARTHEN)
(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2026

WHEREAS the Carmarthenshire County Council (hereinafter referred to as "the Council") being the Highway Authority for that length of Road known as C1301 Llanpumsaint to Bancyffordd from a point 125 metres South of its junction with the C1305 for a distance of approximately 1¼ mile in a South Easterly direction.

NOW therefore the Council in exercise of their powers under Section 14(1) of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers hereby make the following Order:-

1. No person shall cause any vehicle to proceed along that length of the Road known as C1301 Llanpumsaint to Bancyffordd from a point 125 metres South of its junction with the C1305 for a distance of approximately 1¼ mile in a South Easterly direction.
2. This Order shall come into operation on the Twenty Ninth day of January Two Thousand and Twenty-Six and may be cited as The County of Carmarthenshire (C1301 Llanpumsaint to Bancyffordd, Carmarthen) (Temporary Prohibition of Through Traffic) Order 2026.
