

THE COUNTY OF CARMARTHENSHIRE
(C2076 HEOL MEINCIAU MAWR, MEINCIAU (SA17 5LF))
(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2026

WHEREAS the Carmarthenshire County Council (hereinafter referred to as "the Council") being the Highway Authority for that length of Road known as the C2076 Heol Meinciau Mawr, Meinciau (SA17 5LF) from its junction with the C2057 for a distance of 285 metres in a North Easterly direction.

NOW therefore the Council in exercise of their powers under Section 14(1) of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers hereby make the following Order:-

1. No person shall cause any vehicle to proceed along that length of the Road known as the C2076 Heol Meinciau Mawr, Meinciau (SA17 5LF) from its junction with the C2057 for a distance of 285 metres in a North Easterly direction.

2. This Order shall come into operation on the Second day of March Two Thousand and Twenty-Six and may be cited as The County of Carmarthenshire (the C2076 Heol Meinciau Mawr, Meinciau (SA17 5LF)) (Temporary Prohibition of Through Traffic) Order 2026.
