

THE COUNTY OF CARMARTHENSHIRE
(C2204 NEAR THE PROPERTY GLYNFACH FARM PONTYATES (SA15 5TN))
(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2026

WHEREAS the Carmarthenshire County Council (hereinafter referred to as "the Council") being the Highway Authority for that length of Road known as the C2204 near the property Glynfach Farm, Pontyates, SA15 5TN from its junction with the C2204 to its junction with the U2225 for a distance of 356 metres in a North Westerly direction.

NOW therefore the Council in exercise of their powers under Section 14(1) of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers hereby make the following Order:-

1. No person shall cause any vehicle to proceed along that length of the Road known as the C2204 near the property Glynfach Farm, Pontyates, SA15 5TN from its junction with the C2204 to its junction with the U2225 for a distance of 356 metres in a North Westerly direction.
2. This Order shall come into operation on the Sixteenth day of January Two Thousand and Twenty-Six and may be cited as The County of Carmarthenshire (C2204 near the property Glynfach Farm, Pontyates, SA15 5TN) (Temporary Prohibition of Through Traffic) Order 2026.
