

THE COUNTY OF CARMARTHENSHIRE
(C2118 & U4002, CAPEL ISAAC, LLANDEILO)
(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2025

WHEREAS the Carmarthenshire County Council (hereinafter referred to as "the Council") being the Highway Authority for that length of Road known as the C2118 Capel Isaac from a point 293 metres Southeast of its junction with the C2154 for a distance of 440 metres in a Southerly direction to its junction with the U4002 and the U4002 Capel Isaac from its junction with the C2118 for a distance of 150 metres in a Westerly direction.

NOW therefore the Council in exercise of their powers under Section 14(1) of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers hereby make the following Order:-

1. No person shall cause any vehicle to proceed along that length of the Roads known as the C2118 Capel Isaac from a point 293 metres Southeast of its junction with the C2154 for a distance of 440 metres in a Southerly direction to its junction with the U4002 and the U4002 Capel Isaac from its junction with the C2118 for a distance of 150 metres in a Westerly direction.
2. This Order shall come into operation on the Sixth day of January Two Thousand and Twenty Six and may be cited as The County of Carmarthenshire (C2118 and U4002 Capel Isaac, Llandeilo) (Temporary Prohibition of Through Traffic) Order 2025.
