

THE COUNTY OF CARMARTHENSHIRE
(C2053 NEAR GRAIG-YR-AFAR, PONTARGOTHI)
TEMPORARY PROHIBITION OF TRAFFIC ORDER 2026

WHEREAS the Carmarthenshire County Council (hereinafter referred to as "the Council") being the Highway Authority for that length of are satisfied that traffic in the said length of road known as the C2053 near the property Graig-yr-Afar, Pont ar Gothi (SA43 7NP) from a point 1.5 Kilometres North East of its junction with the TRA40 for a distance of 531 metres in a North Easterly direction should be restricted by reason of the works proposed to be executed thereon.

NOW therefore the Council in exercise of their powers under Section 14(1) of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other enabling powers hereby make the following Order:-

1. No person shall cause any vehicle to proceed along that length of road known as the C2053 near the property Graig-yr-Afar, Pont ar Gothi (SA43 7NP) from a point 1.5 Kilometres North East of its junction with the TRA40 for a distance of 531 metres in a North Easterly direction

2. This Order shall come into operation on the 6th April 2026 and may be cited as The County of Carmarthenshire (C2053 near Graig-yr-Afar, Pont ar Gothi) (Temporary Prohibition of Through Traffic) Order 2026.


