

THE COUNTY OF CARMARTHENSHIRE
(C2056 and U4442, DRYSLWYN)
(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2025

WHEREAS the Carmarthenshire County Council (hereinafter referred to as "the Council") being the Highway Authority for that length of Road known as C2056 Dryslwyn, Carmarthen from its junction with the C2055 for a distance of 686 metres in a North Westerly direction and the U4442 from Dryslwyn from its junction with the C2055 for a distance of 625 metres in a South Westerly direction.

NOW therefore the Council in exercise of their powers under Section 14(1) of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers hereby make the following Order:-

1. No person shall cause any vehicle to proceed along that length of the Road known as C2056 Dryslwyn, Carmarthen from its junction with the C2055 for a distance of 686 metres in a North Westerly direction and the U4442 from Dryslwyn from its junction with the C2055 for a distance of 625 metres in a South Westerly direction.
2. This Order shall come into operation on the Third day of November Two Thousand and Twenty-Five and may be cited as The County of Carmarthenshire (C2055 and U4442 Dryslwyn) (Temporary Prohibition of Through Traffic) Order 2025.
