

**THE COUNTY OF CARMARTHENSHIRE**  
**(C2157 LLANDOVERY)**  
**(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2026**

---

**WHEREAS** the Carmarthenshire County Council (hereinafter referred to as "the Council") being the Highway Authority for that length of Road known as the C2157 Llandoverly, from a point 712 metres south west of its junction with the C2163 Cilycwm, for a distance of 102 metres in a south westerly direction are satisfied that traffic in the said length of road should be restricted by reason of the works proposed to be executed thereon.

**NOW** therefore the Council in exercise of their powers under Section 14(1) of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers hereby make the following Order:-

1. No person shall cause any vehicle to proceed along that length of the C2157 Llandoverly, from a point 712 metres south west of its junction with the C2163 Cilycwm, for a distance of 102 metres in a south westerly direction.
2. This Order shall come into operation on the Twenty-Seventh day of April Two Thousand and Twenty-Six and may be cited as The County of Carmarthenshire (C2157 Llandoverly) (Temporary Prohibition of Through Traffic) Order 2026.
