

CYNGOR SIR CAERFYRDDIN
CARMARTHENSHIRE COUNTY COUNCIL
ORDER UNDER SECTION 21 OF THE TOWN POLICE CLAUSES ACT
1847
FOR THE PREVENTION OF OBSTRUCTION

Whereas from 19:00 hours on Thursday 13th November 2025 to 06:00 hours on Monday 17th November 2025, Carmarthen Street (located between Carmarthen Road and Rhosmaen Street) from a point 115 metres south-east of its junction with New Road, to its junction with the A484 Rhosmaen Street; Market Street (located between Carmarthen Street and King Street) and King Street (located between Bridge Street and George Hill), Llandeilo, will be thronged and liable to be obstructed.

The CARMARTHENSHIRE COUNTY COUNCIL pursuant to powers conferred by Section 21 of the Town Police Clauses Act 1847 DOES HEREBY ORDER AND DIRECT that for the purpose of preventing obstruction in the said streets, Carmarthen Street, Market Street, and King Street, Llandeilo shall be closed to all vehicular traffic including pedal cycles from 19:00 hours on Thursday 13th November 2025 to 06:00 hours on Monday 17th November 2025, subject to emergency service vehicles being allowed access to the street without delay in the event of an emergency.

The Alternative Route for south-eastbound traffic will be to proceed in a north-easterly direction along New Road to its junction with Rhosmaen Street. At the junction, turn right and continue in a south-westerly direction along Rhosmaen Street and Bridge Street to return to a point south-east of the closure.

Vice versa for North-Westbound traffic.

The County of Carmarthenshire (George Street, Llandeilo) (One-Way Traffic) Order 1974 will be Temporarily Suspended for the duration of the closure.
