THE COUNTY OF CARMARTHENSHIRE (LLANELLI) (WAITING RESTRICTION AND STREET PARKING PLACES) CONSOLIDATION (VARIATION NO. 5) ORDER 2006

THE CARMARTHENSHIRE COUNTY COUNCIL in exercise of its powers under Sections 1(1), 2(1) to (3) and 4(2), 32(1) and 35(1) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as "the Act of 1984") as amended and the Road Traffic Act 1991 and of all other powers them enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and with the Road Traffic Act 1991, hereby make the following Order:-

- 1. The County of Carmarthenshire (Llanelli) (Waiting Restriction and Street Parking Places) Consolidation Order 2004 ("the Consolidation Order") is hereby varied by the attachment thereto of the plans attached to this Order which has the effect of imposing on such parts of the roads identified and for the periods identified in the plan attached to this Order:-
 - (a) prohibition of waiting at any time
 - (b) limited waiting to 1 hour with return prohibited within 1 hour between the hours of 8.00 a.m. and 6.00 p.m. on any day except Sunday
 - (c) prohibition of waiting at any time except for loading and unloading
 - (d) prohibition of waiting with no exemptions for loading and unloading
 - (e) prohibition of parking except for disabled persons in accordance with the provisions of the Consolidation Order.
- 2. The Order shall come into operation on the 21st day of April Two Thousand and Six and may be cited as The County of Carmarthenshire (Llanelli) (Waiting Restriction and Street Parking Places) Consolidation (Variation No. 5) Order 2006.



PUBLIC NOTICE

THE COUNTY OF CARMARTHENSHIRE (LLANELLI) (WAITING RESTRICTION AND STREET PARKING PLACES) CONSOLIDATION (VARIATION NO. 5) ORDER 2006

NOTICE is hereby given that on the 3rd day of April, 2006 the Carmarthenshire County Council made an Order under Section 1(1), 2(1) to (3), 4(2), 32(1) and 35(1) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") as amended by the Road Traffic Act 1991.

The effect of this Order will be to amend The County of Carmarthenshire (Llanelli) (Waiting Restrictions and Street Parking Places) Consolidation Order 2004 ("the Consolidation Order") (which provides for decriminalised enforcement of contraventions of waiting prohibitions and restrictions) by substituting the plans annexed thereto denoting Areas CJ217, CK216, CK217, CL216 and CN213 with the plans annexed to the Order. The consequence of the amendment will:

- 1. Prohibit waiting at any time on the sides of road specified in Schedule 1 to this Notice.
- 2. Limit waiting to 1 hour with return prohibited within 1 hour between the hours of 8.00 a.m. and 6.00 p.m. on any day except Sunday on the sides of road specified in Schedule 2 to this Notice.
- 3. Prohibit waiting at any time on the sides of road specified in Schedule 3 to this Notice except for the loading and unloading of vehicles.
- 4. Prohibit waiting at any time on the sides of road specified in Schedule 4 to this Notice with no exemptions for loading and unloading of vehicles.
- 5. Prohibit parking on the side of road specified in Schedule 5 to this Notice except for disabled persons parked in accordance with the provisions contained in the Consolidation Order and on such days and during such hours as identified on the relevant plan.

and will replace the existing prohibitions and restrictions (if any) that affect the parts of the roads referred to above.

The provisions for the usual exemptions contained in the Consolidation Order will apply in relation to the roads referred to in paragraphs 1 and 2 above. These include the right for passengers to board or alight from a vehicle, for the loading and unloading of goods, for the carrying out of building operations and other works, for the performance of statutory powers or duties, and to enable a vehicle to take in petrol, oil, water or air from any garage situated adjacent to such parts of the roads affected by the proposed restriction.

In addition, the Consolidated Order contains where applicable the usual parking concessions for disabled persons in accordance with the Blue Badge Scheme.

The Order will come into operation on the 21st day of April, 2006 and a copy of the Order, together with maps indicating the roads affected, may be inspected at the offices of the Carmarthenshire County Council at County Hall, Carmarthen during normal office hours.

Any person who desires to question the validity of this Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Act or on the grounds that any requirement of the Act or of any instrument made under it has not been complied with in relation to the Order, may, within six weeks of the date on which the Order was made, apply to the High Court for his purpose.
