

THE COUNTY OF CARMARTHENSHIRE
(C2077 NEAR MYRTLE HILL, PONTHENRI (SA15 5NY))
(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2025

WHEREAS the Carmarthenshire County Council (hereinafter referred to as "the Council") being the Highway Authority for that length of Road known as the C2077 near Myrtle Hill, Ponthenri (SA15 5NY) from its junction with the B4317 for a distance of 564 metres in a general South Easterly direction.

NOW therefore the Council in exercise of their powers under Section 14(1) of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers hereby make the following Order:-

1. No person shall cause any vehicle to proceed along that length of the Road known as the C2077 near Myrtle Hill, Ponthenri (SA15 5NY) from its junction with the B4317 for a distance of 564 metres in a general South Easterly direction.
2. This Order shall come into operation on the Fifth day of January Two Thousand and Twenty-Six and may be cited as The County of Carmarthenshire (C2077 near Myrtle Hill, Ponthenri) (SA15 5NY) (Temporary Prohibition of Through Traffic) Order 2025.
