

**ROAD TRAFFIC REGULATION ACT 1984 SECTION 16(A) AS AMENDED
BY THE ROAD TRAFFIC (TEMPORARY RESTRICTIONS) ACT 1991**

**THE COUNTY OF CARMARTHENSHIRE (SPECIAL EVENTS) (TYWI
VALLEY HALF MARATHON 2026) (TEMPORARY TRAFFIC
MANAGEMENT) ORDER 2026**

WHEREAS the roads specified in the Schedule to this Order form the area designated to be used as the route to enable the Tywi Valley Half Marathon 2026 ("the Event") to take place. Carmarthenshire County Council (hereinafter referred to as "the Council") is the Highway Authority for those lengths of road more particularly referred to in the Schedule to this Order. The organisers of the Event wish to prohibit the use of the lengths of road described in the said Schedule by vehicles and unauthorised bicycles on Sunday 16 August 2026 from 09:00 hours to 12:00 hours for the holding of the Event.

NOW THEREFORE the Council in pursuance of its powers under Section 16A of the Road Traffic Regulation Act 1984 (as amended) and all other enabling powers makes the following Order:

1. Revocation

The County of Carmarthenshire (Special Events) (Tywi Valley Half Marathon 2026) (Temporary Traffic Management) Order 2026 sealed on 7 August 2026 is hereby revoked.

2. Road Closures

The roads more particularly described in the Schedule to this Order shall be closed for the purpose of holding the Event on Sunday 16 August 2026 between 09:00 hours and 12:00 hours.

3. Citation and Commencement

This Order shall come into operation on Sunday 16 August 2026 and may be cited as The County of Carmarthenshire (Special Events) (Tywi Valley Half Marathon 2026) (Temporary Traffic Management) Order 2026.

SCHEDULE

The following roads will be closed between 09:00 hours and 12:00 hours on Sunday 16 August 2026:

1. The C2145, from its junction with the B4300 to its junction with the C2152 (from Cilsane to Penybanc).
2. The B4297, from its junction with the A40 to its junction with the B4300.

The following footpath will be closed between 09:00 hours and 12:00 hours on Sunday 16 August 2026:

1. FP 31/27.
