

THE COUNTY OF CARMARTHENSHIRE
(QUEEN VICTORIA ROAD, LLANELLI)
(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2026

WHEREAS the Carmarthenshire County Council (hereinafter referred to as "the Council") being the Highway Authority for that length of Road known as Queen Victoria Road, Llanelli (SA15 2TR) from its junction with High Street to its junction with Erw Road for a distance of 290 metres in a general North Easterly direction are satisfied that traffic in the said length of road should be restricted by reason of the works proposed to be executed thereon.

NOW therefore the Council in exercise of their powers under Section 14(1) of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers hereby make the following Order:-

1. No person shall cause any vehicle to proceed along that length of Queen Victoria Road, Llanelli (SA15 2TR) from its junction with High Street to its junction with Erw Road for a distance of 290 metres in a general North Easterly direction.
2. This Order shall come into operation on the Twelfth day of August Two Thousand and Twenty-Six and may be cited as The County of Carmarthenshire (Queen Victoria Road, Llanelli) (Temporary Prohibition of Through Traffic) Order 2026.
