

THE COUNTY OF CARMARTHENSHIRE
(THE C2205 HEOL NAZARETH, PONTYATES AND THE C2204 FROM ITS
JUNCTION WITH THE C2205 NAZARETH ROAD)
(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2025

WHEREAS the Carmarthenshire County Council (hereinafter referred to as "the Council") being the Highway Authority for that length of Road known as the C2205 Heol Nazareth, Pontyates (SA15 5TN) from a point 691 metres Southwest of its junction with the B4309 for a distance of 1.3 Kilometres in a general North Westerly direction. Also, the C2204 from its junction with the C2205 Nazareth Road for a distance of 595 metres in a general South Westerly direction.

NOW therefore the Council in exercise of their powers under Section 14(1) of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers hereby make the following Order:-

1. No person shall cause any vehicle to proceed along that length of the Road known as the C2205 Heol Nazareth, Pontyates (SA15 5TN) from a point 691 metres Southwest of its junction with the B4309 for a distance of 1.3 Kilometres in a general North Westerly direction. Also, the C2204 from its junction with the C2205 Nazareth Road for a distance of 595 metres in a general South Westerly direction.
2. This Order shall come into operation on the Eighth day of January Two Thousand and Twenty-Six and may be cited as The County of Carmarthenshire (the C2205 Heol Nazareth, Pontyates and the C2204 from its junction with the C2205 Nazareth Road) (Temporary Prohibition of Through Traffic) Order 2025.

Ni chaniateir i neb beri i unrhyw gerbyd deithio ar hyd y darn hwnnw o'r ffordd a adwaenir fel yr C2205 Heol Nazareth, Pont-iets (SA15 5TN) o fan sydd 691 metr i'r de-orllewin o'r gyffordd â'r B4309 am bellter o 1.3 cilometr i gyfeiriad cyffredinol y gogledd-orllewin. Hefyd, yr C2204 o'r gyffordd â'r C2205 Heol Nazareth am bellter o 595 metr i gyfeiriad cyffredinol y de-orllewin.
