**WHEREAS** the Carmarthenshire County Council (hereinafter referred to as "the Council") being the Highway Authority for that length of Footpath Number 18/16 (Part), Llanboidy specified in Column 1 of the Schedule to this Notice.

**NOW** therefore the Council in exercise of their powers under Section 14(2) of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other enabling powers hereby make the following Order:-

1. No Pedestrians shall proceed along that length of Footpath Footpath Number 18/16 (Part), Llanboidy specified in Column 1 of the Schedule to this Notice.
  
2. This Order shall come into operation on the 11<sup>th</sup> March 2026 and may be cited as The County of Carmarthenshire (Public Footpath Number Footpath Number 18/16 (Part), Llanboidy) Temporary Prohibition of Pedestrians Traffic Order 2026
