

THE COUNTY OF CARMARTHENSHIRE
(C2169 LLANSADWRN, LLANWRDA)
(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2026

WHEREAS the Carmarthenshire County Council (hereinafter referred to as "the Council") being the Highway Authority for that length of Road known as the C2169 Llansadwrn, Llanwrda, from its junction with the C2161 Llansadwrn, for a distance of 180 metres in a south westerly direction.

NOW therefore the Council in exercise of their powers under Section 14(1) of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers hereby make the following Order:-

1. No person shall cause any vehicle to proceed along that length of C2169 Llansadwrn, Llanwrda, from its junction with the C2161 Llansadwrn, for a distance of 180 metres in a south westerly direction.
2. This Order shall come into operation on the Twenty Second day of February Two Thousand and Twenty-Six and may be cited as The County of Carmarthenshire (C2169 Llansadwrn, Llanwrda) (Temporary Prohibition of Through Traffic) Order 2026.
