

THE COUNTY OF CARMARTHENSHIRE
(UNCLASSIFIED ROAD 4488 FROM MANORDEILO, LLANDEILO (BEHIND
GLANBRYDAN FARM) (SA19 7BG))
(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2025

WHEREAS the Carmarthenshire County Council (hereinafter referred to as "the Council") being the Highway Authority for that length of Road known as the Unclassified Road 4488 from Manordeilo, Llandeilo (behind Glanbrydan Farm) (SA19 7BG), from a point 110 metres Northwest of its junction with the TRA40 for a distance of 80 metres in a North Westerly then North Easterly direction.

NOW therefore the Council in exercise of their powers under Section 14(1) of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers hereby make the following Order:-

1. No person shall cause any vehicle to proceed along that length of the Road known as Unclassified Road 4488 from Manordeilo, Llandeilo (behind Glanbrydan Farm) (SA19 7BG), from a point 110 metres Northwest of its junction with the TRA40 for a distance of 80 metres in a North Westerly then North Easterly direction.
2. This Order shall come into operation on the Twenty Fifth day of August Two Thousand and Twenty-Five and may be cited as The County of Carmarthenshire (Unclassified Road 4488 from Manordeilo, Llandeilo (behind Glanbrydan Farm) (SA19 7BG) (Temporary Prohibition of Through Traffic) Order 2025.
