

THE COUNTY OF CARMARTHENSHIRE
(A484, BRONWYDD TO GWILI RAILWAY, CARMARTHEN)
(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2026

WHEREAS the Carmarthenshire County Council (hereinafter referred to as "the Council") being the Highway Authority for that length of Road known the A484, Bronwydd to Gwili Railway, Carmarthen from a point approximately 110 metres Southeast of its junction with the B4301 for a distance of approximately 200 metres in a South Easterly direction.

NOW therefore the Council in exercise of their powers under Section 14(1) of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers hereby make the following Order:-

1. No person shall cause any vehicle to proceed along that length of the Road known as the A484, Bronwydd to Gwili Railway, Carmarthen from a point approximately 110 metres Southeast of its junction with the B4301 for a distance of approximately 200 metres in a South Easterly direction.
2. This Order shall come into operation on the Twenty Sixth day of January Two Thousand and Twenty-Six and may be cited as The County of Carmarthenshire (A484, Bronwydd to Gwili Railway, Carmarthen) (Temporary Prohibition of Through Traffic) Order 2026.
