ORDER UNDER SECTION 21 OF THE TOWN POLICE CLAUSES ACT 1847

FOR THE PREVENTION OF OBSTRUCTION

Whereas on Saturday 22nd August 2026 from 09:00 hours to 17:00 hours, Quay Street, Ammanford will be thronged and liable to be obstructed, from its junction with College Street for a distance of 260 metres in a South-Easterly direction, for Ammanford Vintage Car Show 2026.

The CARMARTHENSHIRE COUNTY COUNCIL pursuant to powers conferred by Section 21 of the Town Police Clauses Act 1847 DOES HEREBY ORDER AND DIRECT that for the purpose of preventing obstruction in the said street, Quay Street, Ammanford shall be closed to all vehicular traffic including pedal cycles on Saturday 22nd August 2026 from 09:00 hours to 17:00 hours, subject to emergency service vehicles being allowed access to the street without delay in the event of an emergency.
