WHEREAS the Carmarthenshire County Council (hereinafter referred to as "the Council") being the Highway Authority for that length of BOAT 57/55 (Part) specified in Column 1 of the Schedule to this Order.

NOW therefore the Council in exercise of their powers under Section 14(2) of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers hereby make the following Order:-

1. No person shall cause any vehicle to proceed along that length BOAT 57/55 (Part) specified in Column 1 of the Schedule to this Order
2. This Order shall come into operation on the Fifteenth day of September Two Thousand and Twenty-Five and may be cited as The County of Carmarthenshire (BOAT 57/55 (Part)) (Temporary Prohibition of Through Traffic) Order 2025.
